PAYMENT PLAN

To register for a journey, submit a completed registration form and a deposit (\$300 for domestic tours, \$500 for international tours, Hawaii and Alaska tours). Please make all payments by check or money order payable to Naturalist Journeys, LLC. We also accept payment by MASTERCARD or VISA. For security reasons, we will take your information for this over the phone, and keep all information confidential. Your signature on the registration form indicates that you have read and agree to abide by the terms and conditions below.

Once you have paid your deposit, the payment schedule is as follows:

- 50% of the remaining balance is due 120 days before the tour start date;
- The final 50% of the balance is due 70 days before the start date;
- Payment in full is required when registering less than 70 days before the start date.

CANCELLATION AND REFUND POLICY

If you need to cancel your participation in a trip for any reason, \$100 of the deposit is non-refundable, but may be applied to another trip within one calendar year. Refunds of the remaining deposit (\$200 or \$400) and any other payments made are as follows:

- In full if you cancel IN WRITING 120 days or more prior to start of trip;
- 50% if you cancel in writing 61 days or more prior to start of trip;
- NO REFUND is available if you cancel if you cancel 60, or less than 60 days prior to start.
