- Please make all payments by check or money order payable to Naturalist Journeys.
- A deposit of \$300.00/person (\$500.00/person for International, Alaska, and Canada trips) is due with this registration and will hold your space.
- 50% of the balance is payable 120 days before the departure date; final payment is due 70 days before the departure date.
- Payment in full is required when booking less than 70 days prior to departure.
- \$ 100.00 of this deposit will be non-refundable, but may be transferred to another program within one calendar year.
- The remaining amount of your deposit, and other tour fees due as outlined in the itinerary will be refundable as follows:
 - In full, with cancellation IN WRITING 120 days prior to departure.
 - 50% refund, less any non-refundable payments made to providers that exceed this amount, with cancellation IN WRITING, 71 days prior to departure.
 - NO REFUND is available less than 70 days prior to departure, though you may find someone to fill your space.
